



Course Name: Cleet Phase IV Firearms  
Classroom: 16 hours/Range: 16 Hours  
Total 32 Hours

### **Course Description:**

This course is required for all persons who want to become licensed armed security officers. You will learn Oklahoma's laws regarding firearms, possession, transport, use of deadly force, handcuffing, and arrest techniques. Instruction will also focus on the handling and firing of a handgun, firearm nomenclature, loading and unloading techniques. Firearm usage will be conducted at an off-campus firing range under close supervision. This course also requires students to show proficiency with their firearms on the range. Training will include 16-hours of classroom learning and 16-hours of on-range instruction and qualifying exercises. Successful completers will have 100% attendance, score 85% or better on written tests, pass all CLEET qualifications on-range, and pass the CLEET Phase IV testing to be eligible for making an application for licensing. No weapons are allowed on campus. Course is CLEET Approved.

### **Prerequisites:**

Must be 21 years old. Phase I & II or III required. Must present MMPI test before enrolling in class. Minimum .38, .45 or 9mm caliber semi-auto pistol, duty style holster, belt and two magazines.

### **Firing Range:**

Students are required to provide 400-450 rounds of NEW ammunition. Reloaded ammo is not allowed to be used in this course. Must provide your own transportation. Must pay \$5.00 for range fee and provide 10-15 shooting targets.

1. List rules for range and firearms safety
2. Describe and demonstrate how to properly maintain a typical revolver
3. Perform the six fundamentals of marksmanship
4. Describe handgun handling skills in stressful situations
5. Demonstrate the four standardized shooting positions
6. Clarify range procedures
7. Explain legal issues associated with being a security officer
